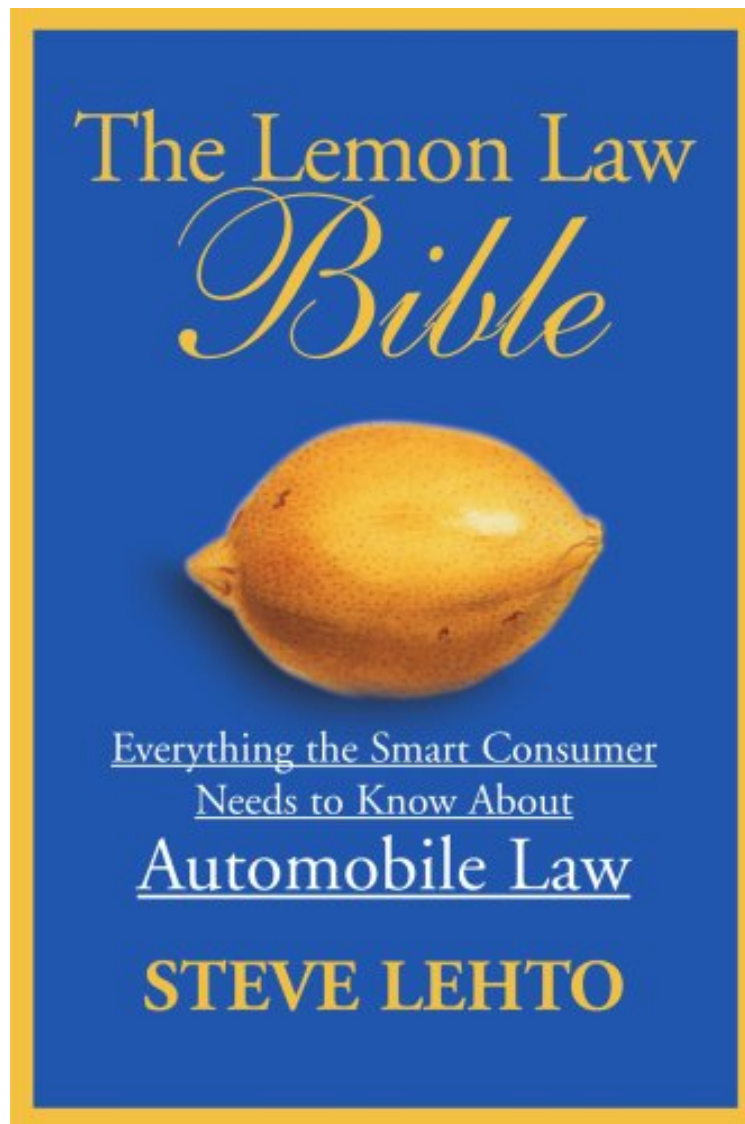

The book contains several appendices which are very helpful including all state and federal laws related to lemons, a sample letter to send the car manufacturer if you believe you have a lemon. The book also gives tips on selecting an attorney to represent you (they should do it at no fee since they will be reimbursed by the car manufacturer if you win), pulling together documentation, etc. The author also makes it clear that it is the manufacturer and not the dealer who is responsible for handling lemons under the law.
